11.25 AM	<p>AUSTRALIAN BUILDING CODES BOARD (ABCB) MARKET UPDATE Anne-Maree Campbell - Director Product Certification - Australian Building Codes Board</p> <p>Delegates will be briefed on the latest updates/amendments to the WaterMark program, aside from Lead-Free, which will be extensively covered in the afternoon session. ABCB management will also detail which Australian Standards relevant to the plumbing industry are coming up for review.</p>
11.45 AM	<p>THE CONTINUING ROLE NATURAL GAS HAS TO PLAY, IN THE DECARBONISATION PATHWAY</p> <p>Gas has and will continue to play a vital role in the broader plumbing/gas industry, but it's not without its challenges. In recent time, a lot of misinformation has been spread about the gas sector, particularly from the 'let's electrify everything' lobby and the Victorian Government, who introduced their ban, effective January 2024. Several States remain supportive of gas, but the sector has lost some of its scalability.</p> <p>Natural gas can be the nucleus of our transition to renewable energies and carbon reduction. Transitioning to hydrogen can be obtained by utilizing the current natural gas networks. High energy gaseous fuel is needed by many industries. The transition to hydrogen will allow the Australian manufacturing sector to maintain its current operations and expand in the future. Australian industry is aware it needs a skilled-up ongoing gas service sector. These embedded skills and past knowledge of plumbing and gas-fitting must continue to be maintained and built upon.</p> <p>This session will provide a national industry update presented by gas industry leaders, using the latest data, and will explore both conventional and hydrogen gas development options, which are virtually changing by the day.</p> <p>Speakers: Enzo Alfonsetti - Head of Gas Installation and Equipment Safety - Energy Safe Victoria : Paul Bonsak - Managing Director - IAPMO Oceania</p>
